KAIROS INVESTMENTS (PAN: AANFK2264M): Kairos Investments is a Partnership Firm and said Firm has been dissolved with effect from the close of business on 31st day of March, 2019. Kairos Investments therefore shall not be considered as Part of the Promoter Group, from close of business on 31st day of March, 2019 and thereafter. Since Kairos Investments was holding NIL shares in Company, there is no change in shareholding of Promoter and Promoter Group, due to dissolution of said entity. 2. PUDUMJEE HOLDING LIMITED (PAN: AAGCP2877H) and 3. PUDUMJEE HYGIENE PRODUCTS LIMITED (PAN: AADCP3446K): Pudumjee Holding Limited (PHL) and Pudumjee Hygiene Products Limited (PHPL) has merged with 3P Land Holdings Limited (Formerly known as Pudumjee Industries Limited) vide a Scheme of Amalgamation, approved by Honble National Company Law Tribunal, vide Order dated 14th December, 2018 (Order). Pursuant to the filing of the Order with Registrar of Companies and approval thereof, the said companies show status as amalgamated on the MCA website. PHL and PHPL, therefore, are no longer in existence as of 31st March, 2019 and do not form part of the Promoter Group, as of 31st day of March, 2019 and thereafter. Prior to the afore-mentioned amalgamation, PHL and PHPL held 2,25,000 & 20,000 equity shares respectively in Company. Post amalgamation, these equity shares are held by 3P Land Holdings Limited (Formerly known as Pudumjee Industries Limited). C. The Company has received letter dated 16th April, 2019 from Yashvardhan Jatia Trust confirming its compliance with the Exemption Order No. SEBI/WTM/SR/CFD-DCR/14/03/2017 dated 09th March, 2017, for financial year 2018-19..
