A. We additionally submit the following information regarding entities which were part of the Promoter Group as on 30th September, 2020 but due to changes, cannot be deemed as continuing to be part of the Promoter Group of the Company as of 31st December, 2020: 1. POONAM JATIA FAMILY TRUST (PAN: AADAP2514L): Poonam Jatia Family Trust is a Family Trust and said Trust does not exist as on 31st December, 2020. Poonam Jatia Family Trust therefore shall not be considered as Part of the Promoter Group of the Company. Since Poonam Jatia Family Trust was holding NIL shares in Company, there is no change in shareholding of Promoter and Promoter Group. 2. PUDUMJEE INVESTMENT & FINANCE COMPANY LIMITED (PAN: AABCP0080D): Pudumjee Investment & Finance Company Limited (PIFCO) has merged with AMJ Land Holdings Limited vide a Scheme of Merger by Absorption, approved by Honble National Company Law Tribunal, Mumbai Bench vide its Order dated 15th October, 2020 (Order). Pursuant to the filing of the said Order with Registrar of Companies and approval thereof, the said company (i.e. PIFCO) show status as Amalgamated on the MCA website. PIFCO, therefore, is no longer in existence as of 31st December, 2020 and do not form part of the Promoter Group, as of 31st December, 2020 and thereafter. Prior to the abovementioned merger, PIFCO held 17,75,605 equity shares in Company. Post merger, these equity shares are held by AMJ Land Holdings Limited pursuant to the said Order.
